7 **A Resolution confirming the award by the Board of Control, subject to the approval of the**  
8 **Information Technology Board, of a professional service contract with Kronos, Inc., as a**  
9 **Sole Source, for UKG Pro Timekeeping Hourly and UKG Pro Absence, for a three-year**  
10 **term, in an amount not to exceed \$565,484.08, for the Office of Information Technology,**  
11 **and declaring an emergency.**

13 WHEREAS, Kronos, Inc. implemented the County’s time-tracking system and is a Sole  
14 Source for the software and services for that system; and

15  
16 WHEREAS, the Office of Information Technology recommends that the County enter a  
17 professional service contract with Kronos, Inc., as a Sole Source, for UKG Pro Timekeeping  
18 Hourly and UKG Pro Absence, for a three-year term, for services in an amount not to exceed  
19 \$181,152.00 for year one, with a 4% increase for years two and three, for a total amount not to  
20 exceed \$565,484.08; and

22 WHEREAS, the Board of Control, at its meeting held June 12, 2024, awarded said  
23 professional service contract, subject to the approval of the Information Technology Board, with  
24 Kronos, Inc., as a Sole Source, subject to confirmation by this Council; and

26 WHEREAS, the Information Technology Board, at its meeting held June 25, 2024, will  
27 consider said professional service contract with Kronos, Inc.; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that aforementioned professional service contract, subject to the approval of the Information  
31 Technology Board, with Kronos, Inc. is necessary and in the best interest of the County of  
32 Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that;

39 The award by the Board of Control a professional service contract with Kronos, Inc.,  
40 subject to the approval of the Information Technology Board, for UKG Pro Timekeeping Hourly  
41 and UKG Pro Absence, as a Sole Source, for a three-year term, in an amount not to exceed  
42 \$565,484.08, is hereby confirmed and the Executive is hereby authorized to execute said  
43 professional service contract and any other necessary related documents.

47 This Resolution is hereby declared an emergency in the interest of the health, safety and  
48 welfare of the residents of the County of Summit, and for the further purpose to immediately  
49 authorize a necessary contract to maintain the County’s time-tracking system for County  
50 employees.

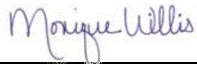
