WHEREAS, a Collective Bargaining Agreement has been reached between Local 1032 of the American Federation of State, County and Municipal Employees, AFL-CIO (Service and Maintenance Unit) and the Executive and the Engineer, for the period 4/1/24 through 3/31/27, with an increase in pay of three and one-half percent (3.5%) in the first year of the agreement (4/1/24), three percent (3.0%) in the second year of the agreement (4/1/25), and two and one-half percent (2.5%) in the third year of the agreement (4/1/26); and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the Executive to execute the aforementioned Collective Bargaining Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

The Executive is hereby authorized to execute a Collective Bargaining Agreement between Local 1032 of the American Federation of State, County and Municipal Employees, AFL-CIO (Service and Maintenance Unit) and the Executive and the Engineer, for the period 4/1/24 through 3/31/27, with an increase in pay of three and one-half percent (3.5%) in the first year of the agreement (4/1/24), three percent (3.0%) in the second year of the agreement (4/1/25), and two and one-half percent (2.5%) in the third year of the agreement (4/1/26).

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the for the further purpose of providing a timely Collective Bargaining Agreement between the Local 1032 of the American Federation of State, County and Municipal Employees, AFL-CIO (Service and Maintenance Unit), and the Executive and the Engineer.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
