7 **A Resolution confirming the award by the Board of Control of a purchase contract with**  
8 **Tyler Technologies, Inc., as a Best Practical Source, to provide annual maintenance services**  
9 **for the county-wide computer-aided dispatch and records management systems, for the**  
10 **period 7/1/24 through 6/30/25, in an amount not to exceed \$485,311.38, for the Executive’s**  
11 **Department of Public Safety, and declaring an emergency.**

12

13 WHEREAS, the Executive previously contracted with Tyler Technologies, Inc. to provide  
14 county-wide computer-aided dispatch (CAD) and records management system services for  
15 communities in Summit County; and

16

17 WHEREAS, the CAD Oversight Committee members pay user fees, proportionally based  
18 on their usage, to support ongoing costs related to the system; and

19

20 WHEREAS, the CAD Oversight Committee approved the year 6 annual maintenance cost  
21 with Tyler Technologies at its November 2023 meeting; and

22

23 WHEREAS, Tyler Technologies, Inc. is a Best Practical Source pursuant to Sections  
24 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit because the  
25 maintenance services provided are for a proprietary system already being utilized for countywide  
26 system services; and

28 WHEREAS, the Board of Control, at its meeting on June 26, 2024, awarded the  
29 aforementioned purchase contract with Tyler Technologies, Inc., as Best Practical Source, to  
30 provide annual maintenance services for the county-wide computer-aided dispatch and records  
31 management systems, for the period 7/1/24 through 6/30/25, in an amount not to exceed  
32 \$485,311.38, subject to confirmation by this Council; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
35 that the aforementioned purchase contract with Tyler Technologies, Inc. is necessary and in the  
36 best interest of the County of Summit;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that:

43 The award of a purchase contract with Tyler Technologies, Inc., as Best Practical Source,  
44 to provide annual maintenance services for the county-wide computer-aided dispatch and records  
45 management systems, for the period 7/1/24 through 6/30/25, in an amount not to exceed  
46 \$485,311.38, is hereby confirmed and the Executive is hereby authorized to execute said purchase  
47 contract and any other necessary documentation.

14 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
15 be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action, were

23 121.22 of the Ohio Revised Code.




