7 **A Resolution authorizing the Executive to execute, subject to the approval of the Board of**
8 **Control and the Information Technology Board, a purchase contract with 460 Tech, LLC.**
9 **dba BeInCourt, as a Best Practical Source, to provide annual maintenance with on-site**
10 **support, for the Criminal Justice Virtual Courtroom Project, for the term of 7/1/24 through**
11 **6/30/25, for a total cost not to exceed \$322,492.00, for the Executive’s Department of Public**
12 **Safety, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2020-358, which approved a
15 professional service contract with ExhibitOne Corp., to provide hardware and software to support
16 county-wide virtual courtroom proceedings for criminal justice stakeholders throughout Summit
17 County; and

18
19 WHEREAS, this Council subsequently adopted Resolution No. 2023-039, which approved
20 a purchase contract with 460 Tech, LLC dba BeInCourt (“BeInCourt”), to provide one year of
21 maintenance on hardware and software for the county-wide virtual courtroom project, for the term
22 of 7/1/23 through 6/30/24; and

24 WHEREAS, this purchase contract includes the hardware and software that was installed
25 as part of the virtual court room project and includes on-site support, for the term of 7/1/24 through
26 6/30/25, for a total cost not to exceed \$322,492.00; and

28 WHEREAS, BeInCourt is a Best Practical Source pursuant to Sections 177.01(h)(4)D. and
29 177.07(a)(5) of the Codified Ordinances of the County of Summit because the maintenance
30 services provided are for a proprietary system already being utilized for the virtual courtroom
31 project since its inception; and

33 WHEREAS, the Information Technology Board, at its meeting to be held on June 25, 2024,
34 will consider the aforementioned purchase contract with BeInCourt; and

36 WHEREAS, the Board of Control, at its meeting to be held on June 26, 2024, will consider
37 the aforementioned purchase contract with BeInCourt; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that the aforementioned purchase contract with BeInCourt, subject to approval of Board of Control
41 and the Information Technology Board, is necessary and in the best interest of the County of
42 Summit;

44 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

49 The Executive is hereby authorized to execute, subject to the approval of the Board of
50 Control and the Information Technology Board, a purchase contract and any other necessary
51 related documents, with 460 Tech, LLC. dba BeInCourt, to provide annual maintenance with on-
52 site support, for the Criminal Justice Virtual Courtroom Project, for the term of 7/1/24 through

17 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
18 be in force at the earliest time provided by law.
