7 **A Resolution authorizing the Executive to execute a grant agreement with AxessPointe**
8 **Community Health Centers to finance the construction of fiber to the new I Promise Health**
9 **Quarters, located at 527 West Market St., in the City of Akron, in Council District 4, in a**
10 **total amount not to exceed \$250,000.00, for the Executive, and declaring an emergency.**

12 WHEREAS, the I Promise Health Quarters (“IPHQ”) is a comprehensive community
13 health and wellness center that provides medical, dental, optometry, and mental health services
14 as well as pharmacy and lab services to all residents in Summit County; and

15

16 WHEREAS, the IPHQ is currently located at 527 West Market St., in the City of Akron,
17 in Council District 4; and

18

19 WHEREAS, reliable internet service is imperative for the function of the IPHQ; and

20

21 WHEREAS, AxessPointe Community Health Centers (“AxessPointe”) has contracted for
22 the construction of the fiber infrastructure needed to provide the necessary internet service for
23 the facility; and

25 WHEREAS, the Executive wishes to provide a grant to AxessPointe to fund the fiber
26 build out to IPHQ in order to support the mission of AxessPointe; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 execute a grant agreement with AxessPointe:

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The Executive is hereby authorized to execute a grant agreement and any other necessary
38 related documents with AxessPointe Community Health Centers the construction of fiber to the
39 new I Promise Health Quarters, located at 527 West Market St., in the City of Akron, in Council
40 District 4, in a total amount not to exceed \$250,000.00.

45 This Resolution is hereby declared an emergency in the interest of the health, safety, and
46 welfare of the residents of the County of Summit, and for the further reason to immediately
47 approve the aforementioned grant agreement in order to enable AxessPointe Community Health
48 Centers to begin this project.




