7 **A Resolution naming the currently unnamed roadway between Hummel Drive and Dorwil**
8 **Drive “Straub-Eubank Lane” in Coventry Township per the wishes of the Coventry**
9 **Township Trustees, for the Council, and declaring an emergency.**

11 WHEREAS, Ohio Revised Code Section 5541.04 provides counties the authority to
12 change the name of roads in unincorporated areas by resolution; and

13

14 WHEREAS, there exists an unnamed roadway in Coventry Township between Hummel
15 Drive and Dorwil Drive, also known as Township Highway No. 1221, description attached
16 hereto as Exhibit A; and

17

18 WHEREAS, on June 13, 2024, the Coventry Township Trustees adopted a motion
19 naming the aforementioned unnamed roadway between Hummel Drive and Dorwil Drive
20 “Straub-Eubank Lane,”; and

22 WHEREAS, the Coventry Township trustees cited at their June 13, 2024 meeting that
23 William and Marilyn Straub and Carol Eubank were actively involved residents in the Portage
24 Lakes community and should be recognized through naming the road in their honor; and

26 WHEREAS, establishing an identifying name for all roadways in Coventry Township is
27 important for the safety of its residents; and

29 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
30 State of Ohio, that:

32 SECTION 1

34 This Council hereby names the roadway between Hummel Drive and Dorwil Drive
35 “Straub-Eubank Lane,” per the wishes of the Coventry Township Trustees.

39 The Clerk of Council is hereby directed to provide a certified copy of this resolution to
40 the Summit County Engineer and Summit County Fiscal office, per the requirements of Ohio
41 Revised Code Section 5541.04.

43 SECTION 3

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the residents of the County of Summit, and for the further purpose to immediately
47 name the roadway between Hummel Drive and Dorwil Drive “Straub-Eubank Lane,” per the
48 wishes of the Coventry Township Trustees.


