7 **A Resolution authorizing the Executive to advertise for bids for the Courthouse Exterior**
8 **Project, located in the City of Akron, in Council District 4, for an estimated total cost not to**
9 **exceed \$150,000.00, for the Executive’s Department of Administrative Services-Physical**
10 **Plants Division, and declaring an emergency.**

12 WHEREAS, the Domestic Relations Courthouse was constructed in 2004 and is need of
13 cleaning the concrete façade; and

14

15 WHEREAS, the Courthouse Exterior Project (the “Project”) will consist of the concrete
16 façade being power washed, having the mortar joints caulked and repaired and having a final seal
17 coat applied to protect the concrete; and

18

19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
20 requires this Council’s authorization for the Executive to advertise for bids; and

21

22 WHEREAS, the Executive wishes to advertise for bids for the Project, located in the City
23 of Akron, in Council District 4, for an estimated total cost not to exceed \$150,000.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council’s office;

28 WHEREAS this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the Project;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The Executive is hereby authorized to advertise for bids for the Courthouse Exterior
38 Project (the “Project”), located in the City of Akron, in Council District 4, for an estimated total
39 cost not to exceed \$150,000.00.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids in order for the Project to proceed as expeditiously
46 as possible.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
