WHEREAS, the Engineer is undertaking the Valley View Road Resurfacing Project (the "Project"), to complete rehabilitation and resurfacing of existing roadway which will be milled, widened and overlayed from approximately 400 feet west of the intersection with Olde 8 Road to the intersection of Dunham Road, located in Sagamore Hills Township, in Council District 1; and

WHEREAS, the Project will also address any substandard shoulders to the roadway which will be widened and improved where possible and the existing cross slopes will be maintained. The northwest bound approach to the intersection with North Boyden Road will be widened to accommodate a revised lane configuration of a dedicated left turn; and

WHEREAS, the Engineer will receive funding from the Ohio Department of Transportation for ninety percent (90%) of eligible costs toward the construction of the Project up to a maximum amount of \$787,500.00; and

WHEREAS, the cost of this construction contract is considered a local cost to be funded out of the Motor Vehicle and Gas Tax; and

WHEREAS, after receipt and review of four bid packages, the Executive selected Kenmore Construction Co., Inc., as the lowest responsive and responsible bidder, for the Project; and

WHEREAS, the Board of Control, at its meeting held September 3, 2025, awarded a construction contract with Kenmore Construction Co., Inc., as the lowest responsive and responsible bidder, for the Project, located in Sagamore Hills Township, in Council District 1, in a total amount not to exceed \$921,156.72, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Kenmore Construction Co., Inc. is necessary and in the best interest of the County of Summit; and
