7 **A Resolution authorizing the Executive to execute a HOME Investment Partnership**
8 **Program contract with Restore Addiction Recovery, to support the conversion of an**
9 **approximately 3600 square foot building, at 552 Swartz Avenue, located in Coventry**
10 **Township, in Council District 8, into “Launch House,” a facility to provide a residential**
11 **program for men struggling with drug and/or alcohol addiction, in an amount not to**
12 **exceed \$190,000.00, for the Executive’s Department of Community and Economic**
13 **Development, and declaring an emergency.**

14

15 WHEREAS, the Department of Community and Economic Development receives HOME
16 Investment Partnership funds from the U.S. Department of Housing and Urban Development;
17 and

19 WHEREAS, the Executive wishes to enter into a HOME Investment Partnership Program
20 contract with Restore Addiction Recovery, to convert an approximately 3600 square foot
21 building, which was formerly used as a church, into “Launch House,” a facility to provide a
22 residential program for men struggling with drug and/or alcohol addiction, at 552 Swartz
23 Avenue, located in Coventry Township, in Council District 8, in an amount not to exceed
24 \$190,000.00; and

26 WHEREAS, the remodeled building will consist of approximately five bedrooms, two
27 bathrooms, a kitchen, and general living area for the residents; and

29 WHEREAS, Restore Addiction Recovery provides a clinically supported 12-month
30 residential program for men struggling with drug and/or alcohol addiction in Summit County;
31 and

33 WHEREAS, this project advances the mission of the County’s Opioid Abatement
34 strategy, as this project will expand the capacity for treatment in Summit County; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
38 execute the aforementioned HOME Investment Partnership Program contract with Restore
39 Addiction Recovery; and

41 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The Executive is hereby authorized to execute a HOME Investment Partnership Program
47 contract and any necessary related documents with Restore Addiction Recovery, to support the
48 conversion of an approximately 3600 square foot building, at 552 Swartz Avenue, located in
49 Coventry Township, in Council District 8, into “Launch House,” a facility to provide a
50 residential program for men struggling with drug and/or alcohol addiction, in an amount not to
51 exceed \$190,000.00.

15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and of any of its committees that resulted in such formal action,




