A Resolution authorizing the Executive to execute a lease agreement with IndusPAD, LLC., subject to the approval of the Board of Control, for the lease of approximately 26,000 square feet of the front parking lot of the building located at 450 Grant Street, in the City of Akron, in Council District 4, for a three-month term from 9/1/24 to 12/1/24, for a total amount not to exceed \$5,000.00 for the length of the agreement, for the Summit County Board of Elections, and declaring an emergency.

WHEREAS, IndusPAD, LLC. (City) owns real property located at 450 Grant Street, located in the City of Akron, in Council District 4; and

WHEREAS, the Summit County Board of Elections intends to utilize the parking lot in front of the building located at 450 Grant Street during the early voting period of the 2024 general election in order to place a voter drop box and route cars through the lot to drop off voter ballots; and

WHEREAS, the proposed lease agreement is attached hereto as Exhibit A, and incorporated herein, contains monthly lease payments for a total amount not to exceed \$5,000.00 for the length of the agreement; and

WHEREAS, pursuant to §177.15(d) of the Codified Ordinances of the County of Summit, leases require authorization of Council; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to enter into the aforementioned lease agreement with IndusPAD, LLC.;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## **SECTION 1**

The Executive is hereby authorized to execute a lease agreement with IndusPAD, LLC., subject to the approval of the Board of Control, for the lease of approximately 26,000 square feet of the front parking lot of the building located at 450 Grant Street, in the City of Akron, in Council District 4, for a three-month term from 9/1/24 to 12/1/24, for a total amount not to exceed \$5,000.00 for the length of the agreement, for the use by the Board of Elections for early voting for the 2024 general election. The agreement will be in substantially the same form as Exhibit A, attached hereto and incorporated herein as if fully restated.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose to immediately allow the Board of Elections to begin using the parking lot located on the property.
