7 **A Resolution authorizing the Executive to execute, subject to the approval of the Board of**  
8 **Control, a professional service contract with Milano Cleaning Services, Inc., to provide**  
9 **janitorial services at the Consolidated Dispatch Center, located in the City of Tallmadge, in**  
10 **Council District 6, for the term of 9/1/24 through 12/31/25, with four options to renew for**  
11 **additional one-year terms, in an amount not to exceed \$78,234.40 per year, for the**  
12 **Executive’s Department of Public Safety, and declaring an emergency.**

14 WHEREAS, this professional service contract includes janitorial services for at least six  
15 days a week at the consolidated dispatch center, located at 630 North Ave., in the City of  
16 Tallmadge, in Council District 6, at a cost of \$4889.65 per month; and

18 WHEREAS, the professional service contract will be paid for with Common Area  
19 Maintenance (CAM) funds; and

21 WHEREAS, the Board of Control, at its meeting to be held on September 18, 2024, will  
22 consider the aforementioned professional contract with Milano Cleaning Services; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that the aforementioned professional services contract with Milano Cleaning Services, Inc., is  
26 necessary and in the best interest of the County of Summit;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The Executive is authorized to execute, subject to the approval of the Board of Control, a  
34 professional services contract with Milano Cleaning Services, Inc, for janitorial services in an  
35 amount not to exceed \$78,234.40, is hereby confirmed and the Executive is hereby authorized to  
36 execute said purchase contract and any other necessary related documents.

40 This Resolution is hereby declared an emergency in the interest of health, safety and  
41 welfare of the residents of the County of Summit to provide janitorial services for the consolidated  
42 dispatch center.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
47 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
48 be in force at the earliest time provided by law.
