7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Advanced Eco Systems, Inc. for forty (40) HazMat suits for the Summit County Special**
9 **Operations Response Team-HazMat Branch, for a total amount not to exceed \$78,262.40,**
10 **for the Executive’s Department of Public Safety, Emergency Management Agency, and**
11 **declaring an emergency.**

13 WHEREAS, the County is the fiscal agent for the State Homeland Security Program
14 (“SHSP”) grant for the Ohio Homeland Security Region 5, which is comprised of 13 counties
15 throughout Northeast Ohio; and

16

17 WHEREAS, this Council previously adopted Resolution No. 2024-200, which authorized
18 the Executive to advertise for bids for sixty (60) Hazmat Suits for the Summit County Hazardous
19 Materials Response (HazMat) Team, for an estimated total cost not to exceed \$141,300.00; and

20

21 WHEREAS, due to this project being previously bid twice and substantial time delays in
22 obtaining the required equipment, First Reading Passage is being requested to ensure that the
23 Executive’s Department of Public Safety, Emergency Management Agency can proceed in a
24 timely manner with this contract; and

26 WHEREAS, the Executive wishes to enter into a purchase contract with Advanced Eco
27 Systems, Inc. for forty (40) HazMat Suits for the Summit County Special Operations Team-
28 HazMat Branch, for an amount not to exceed \$78,262.40; and

29

30 WHEREAS, these HazMat suits will replace suits that are near the end of life, to ensure
31 continued capabilities and effective response to hazmat incidents throughout the region; and

33 WHEREAS, said equipment will be fully grant-funded through the SHSP grant; and

35 WHEREAS, the Board of Control, at its meeting held on September 24, 2024, award said
36 purchase contract with Advance Eco Systems, Inc., as the lowest responsive and responsible
37 bidder, subject to confirmation by this Council; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that is necessary and in the best interest of the County of Summit to authorize the Executive to
41 enter into a purchase contract for the aforementioned equipment;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
44 of Ohio, that;

48 The award by the Board of Control of a purchase contract Advanced Eco Systems, Inc. for
49 forty (40) HazMat Suits for the Summit County Special Operations Team-HazMat Branch, for an
50 amount not to exceed \$78,262.40, is hereby confirmed and the Executive is hereby authorized to
51 execute said purchase contract and any other necessary related documents.


