7 **A Resolution authorizing the Executive to advertise for bids for the Parking Lot**
8 **Improvement Project at the Animal Control Facility, located in the City of Akron, in**
9 **Council District 5, for an estimated total cost not to exceed \$150,000.00, for the Executive’s**
10 **Department of Administrative Services–Physical Plants, and declaring an emergency.**

11

12 WHEREAS, the Animal Control Facility was constructed in 2009. The customer
13 parking lot that was constructed of pervious concrete pavement is falling apart and needs to be
14 rebuilt; and

15

16 WHEREAS, the Executive’s Department of Administrative Services–Physical Plants
17 wishes to undertake the Parking Lot Improvement Project at the Animal Control Facility (the
18 “Project”) as the customer lot is crumbling and falling apart causing a safety hazard. The Project
19 will remove the pervious concrete and replace it with conventional asphalt paving; and

21 WHEREAS, the Executive wishes to advertise for bids for the Project, for an estimated
22 total cost not to exceed \$150,000.00; and

24 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
25 requires this Council’s authorization for the Executive to advertise for bids; and

27 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council’s Office;

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that is necessary and in the best interest of the County of Summit to authorize the Executive to
32 advertise for bids for the Project, for an estimated total cost not to exceed \$150,000.00;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

39 The Executive is hereby authorized to advertise for bids for the Parking Lot Improvement
40 Project at the Animal Control Facility, located in the City of Akron, in Council District 5, for an
41 estimated total cost not to exceed \$150,000.00.

45 This Resolution is declared an emergency in the interest of the health, safety, and welfare
46 of the residents of the County of Summit, and for the further reason that it authorizes the
47 Executive to immediately advertisement for bids for necessary improvements to the Animal
48 Control Parking Lot.


