7 **An Amended Resolution, pursuant to Section 169.04(h) of the Codified Ordinances of the**
8 **County of Summit, as set forth in Amended Exhibit A, approving and adopting the Report**
9 **on Staffing for calendar year 2025, for the Executive, and declaring an emergency.**

11 WHEREAS, Section 169.04(h) of the Codified Ordinances of the County of Summit
12 requires the Executive to submit annually a report on staffing which sets forth the number of full-
13 time, part-time, and seasonal positions within each job classification, that an office, department,
14 agency, board, or commission may employ during the following calendar year; and

16 WHEREAS, the Report on Staffing submitted by the Executive must be adopted by this
17 Council no later than December 31st of each year; and

19 WHEREAS, the Executive has submitted to this Council a Report on Staffing for
20 calendar year 2025, which is attached hereto as Amended Exhibit A and incorporated herein by
21 reference; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to adopt the Report on
25 Staffing for calendar year 2025;

27 NOW, THEREFORE BE IT RESOLVED, by the Council of the County of Summit, State

32 The Report on Staffing for calendar year 2025, which is attached hereto as Amended

38 and welfare of the residents of the County of Summit and for the further reason that it is
39 necessary to immediately approve and adopt the Report on Staffing prior to the deadline

45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
