7 **A Resolution authorizing the Executive to enter into an agreement for the acquisition of a**  
8 **Drainage Easement over a portion of 2462 Myersville Road, located in Springfield**  
9 **Township, in Council District 8, in a total amount not to exceed \$300.00, as part of the**  
10 **Myersville Road Culvert Rehabilitation, for the Engineer, and declaring an emergency.**

11  
12 WHEREAS, there is a public need to rehabilitate the Myersville Road Culvert (184-  
13 09108) located in Springfield Township, in Council District 8 (the “Project”); and

14  
15 WHEREAS, certain land must be acquired by the County to be utilized as a drainage  
16 easement as part of the Project; and

17  
18 WHEREAS, acquisition of lands for easements for the Project is considered a local cost,  
19 which must be borne in whole by the local public agency performing the Project; and

20  
21 WHEREAS, the County has negotiated terms for an agreement for the drainage easement  
22 at 2462 Myersville Road, located in Springfield Township, in Council District 8; and

23  
24 WHEREAS, this Council has determined, after reviewing all pertinent information, that it  
25 is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 execute the aforementioned agreement for the acquisition of a drainage easement;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

33 The Executive is hereby authorized to execute agreements for the acquisition of a  
34 drainage easement at 2462 Myersville Road, located in Springfield Township, in Council District  
35 8, in a total amount not to exceed \$300.00, as part of the Myersville Road Culvert Rehabilitation  
36 Project, with the owner of said property, and in the amounts as follows:
