7 **A Resolution authorizing the Executive to enter into agreements for the acquisition of**
8 **Drainage Easements over a portion of 1164 and 1178 Schocalog Road, located in Copley**
9 **Township, in Council District 5, in a total amount not to exceed \$600.00, as part of the**
10 **Schocalog Drainage Improvement Project, for the Engineer, and declaring an emergency.**

12 WHEREAS, there is a public need to repair or replace a culvert on Schocalog Road,
13 located in Copley Township, in Council District 5 (the “Project”); and

14
15 WHEREAS, certain land must be acquired by the County to be utilized as a drainage
16 easement as part of the Project; and

17
18 WHEREAS, acquisition of lands for easements for the Project is considered a local cost,
19 which must be borne in whole by the local public agency performing the Project; and

20
21 WHEREAS, the County has negotiated terms for agreements for the drainage easements
22 at 1164 and 1178 Schocalog Road, located in Copley Township, in Council District 5; and

24 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
25 is necessary and in the best interest of the County of Summit to authorize the Executive to
26 execute the aforementioned agreements for the acquisition of drainage easements;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

33 The Executive is hereby authorized to execute agreements for the acquisition of drainage
34 easements at 1164 and 1178 Schocalog Road, located in Copley Township, in Council District 5,
35 in a total amount not to exceed \$600.00 as part of the Schocalog Road Drainage Improvement
36 Project, with the owners of said property, and in the amounts as follows:
