7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Avertest, LLC dba Averhealth for on-site drug screen testing services, from 12/15/24**
9 **through 12/14/25, with three options to renew for an additional one-year term, in an**
10 **amount not to exceed \$215,820.00, for the Court of Common Pleas-General Division, Adult**
11 **Probation Department, and declaring an emergency.**

13 WHEREAS, the Court of Common Pleas-General Division, Adult Probation Department
14 (the "Court") issued a request for proposals for on-site urine drug screens and other drug testing
15 services for the Adult Probation Department and specialized court dockets; and

16

17 WHEREAS, after receiving and considering five proposals, the Court recommends
18 Avertest, LLC dba Averhealth as the highest scoring and most qualified vendor to provide the
19 aforementioned on-site drug screening services; and

21 WHEREAS, the Board of Control, at its meeting held on November 6, 2024, awarded a
22 purchase contract with Avertest, LLC dba Averhealth for on-site drug screen testing services,
23 from 12/15/24 through 12/14/25, with three options to renew for an additional one-year term, in
24 an amount not to exceed \$215,820.00, subject to confirmation by this Council; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned purchase contract with Avertest, LLC dba Averhealth is necessary and in
28 the best interest of the County of Summit;

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a purchase contract with Avertest, LLC dba
36 Averhealth for on-site drug screen testing services, from 12/15/24 through 12/14/25, with three
37 options to renew for an additional one-year term, in an amount not to exceed \$215,820.00, is
38 hereby confirmed and the Executive is hereby authorized to execute said purchase contract and
39 any other necessary related documents.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further reason to immediately
45 provide necessary drug screen testing services for the Court of Common Pleas-General Division,
46 Adult Probation Department.
