12 the County of Summit; and

15 approving and adopting the 2025 full operating budget for the Executive’s Department of Job
16 and Family Services, as set forth in Exhibit A, attached to this Resolution and incorporated
17 herein as if fully restated, is necessary and in the best interest of the County of Summit;

23 The 2025 full operating budget for the Executive’s Department of Job and Family
24 Services, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully
25 restated is hereby approved and adopted.

29 The Fiscal Officer is hereby authorized and directed to effect the within appropriations as
30 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the residents of the County of Summit and for the further reason that the
36 appropriations contained in Exhibit A are immediately needed for operations of the Executive’s
37 Department of Job and Family Services.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
