7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with Euthenics, Inc. for design services for the Valley View Road (CR25)**
9 **Resurfacing and Landslide Repair Project, located in Sagamore Hills Township, in Council**
10 **District 1, in an amount not to exceed \$518,919.00, for the Engineer, and declaring an**
11 **emergency.**

12

13 WHEREAS, the Engineer is undertaking the Valley View Road (CR25) Resurfacing and
14 Landslide Repair Project (the “Project”), to repair a landslide on Valley View Road located
15 approximately ½ mile east of the Cuyahoga County Line. In addition to the slide repair, the
16 project also includes resurfacing and widening of the shoulders to 4 feet of Valley View Road
17 from the Cuyahoga County Line eastward to Dunham Road, located in Sagamore Hills
18 Township, in Council District 1; and

20 WHEREAS, the Engineer has applied for and received federal funding for the
21 construction of this project. The total construction cost of this project is estimated at
22 \$3,270,000.00, with \$1,800,000.00 from the County Engineers Association of Ohio; and

24 WHEREAS, the cost of this design services contract is considered a local cost to be
25 funded out of the Motor Vehicle and Gas Tax; and

27 WHEREAS, the Engineer requested qualifications from five firms to perform the design
28 work, of which three responded; and

29

30 WHEREAS, after considering the three proposals, the Engineer recommends Euthenics,
31 Inc. as the most qualified firm and the Engineer has negotiated the scope of services; and

33 WHEREAS, the Board of Control, at its meeting held November 27, 2024, awarded a
34 professional service contract with Euthenics, Inc. for design services for the Project, located in
35 Sagamore Hills Township, in Council District 1, in a total amount not to exceed \$518,919.00;

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that the aforementioned professional service contract with Euthenics, Inc. is necessary and in the
40 best interest of the County of Summit; and

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The award by the Board of Control of a professional service contract with Euthenics, Inc.
48 for design services for the Valley View Road (CR25) Resurfacing and Landslide Repair Project
49 (the Project”), located in Sagamore Hills Township, in Council District 1, in a total amount not
50 to exceed \$518,919.00, is hereby confirmed and the Executive is hereby authorized to execute
51 said professional service contract and any other necessary related documents.


