7 **A Resolution authorizing the Executive to enter into agreements for the acquisition of**
8 **Drainage Easements over portions of 5284 Streetsboro Road and the vacant lot located on**
9 **the southeast side of the Medina Line Road and West Streetsboro Road intersection,**
10 **located in Richfield Township, in Council District 1, in a total amount not to exceed**
11 **\$600.00, as part of the Medina Line Road Culvert Rehabilitation Project, for the Engineer,**
12 **and declaring an emergency.**

14 WHEREAS, there is a public need to rehabilitate the Medina Line Road Culvert (002-
15 91870) located in Richfield Township, in Council District 1 (the “Project”); and

16

17 WHEREAS, certain land must be acquired by the County to be utilized as a drainage
18 easement as part of the Project; and

19

20 WHEREAS, acquisition of drainage easements for the Project is considered a local cost,
21 which must be borne in whole by the local public agency performing the Project; and

23 WHEREAS, the County has negotiated terms for agreements for the drainage easements
24 with the owners of 5284 Streetsboro Road and the vacant lot located to the south of West
25 Streetsboro Road and to the east of Medina Line Road, in Richfield Township, in Council
26 District 1; and

28 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
29 is necessary and in the best interest of the County of Summit to authorize the Executive to
30 execute the aforementioned agreements for the acquisition of a drainage easements;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

37 The Executive is hereby authorized to execute agreements for the acquisition of drainage
38 easements at 5284 Streetsboro Road and at the vacant lot located to the southeast of the West
39 Streetsboro Road and Medina Line Road intersection, located in Richfield Township, in Council
40 District 1, in a total amount not to exceed \$600.00 as part of the Medina Line Road Culvert
41 Rehabilitation Project, with the owners of said properties, and in the amounts as follows:


