7 **A Resolution authorizing the Executive to advertise for bids for the purchase of six (6)**
8 **vehicles for the Sheriff’s Office, for an estimated total amount not to exceed \$365,550.00, for**
9 **the Executive and the Sheriff, and declaring an emergency.**

11 WHEREAS, with the support of Congresswomen Emilia Sykes, Summit County was
12 awarded grant funding from the United States Department of Justice of a Bureau of Justice
13 Assistance Fiscal Year 2024 Byrne Discretionary Community Project Grant totaling \$963,000.00
14 and;

16 WHEREAS, the County will utilize \$365,550.00 of said grant proceeds for the purchase
17 and upfit of six (6) police vehicles for the Sheriff’s Office; and

19 WHEREAS, the Executive wishes to advertise for bids for six (6) vehicles for the Sheriff’s
20 Office, for an estimated cost not to exceed \$365,550.00, including five (5) 2025 Ford Explorer
21 Police Interceptors AWD V6, one (1) 2025 Dodge Durango Pursuit Vehicle AWD, and the upfit
22 costs for all six (6) vehicles; and

24 WHEREAS, copies of the bid specifications are on file in the Clerk of Council’s office;

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that is necessary and in the best interest of the County of Summit to authorize the Executive to
29 advertise for bids the aforementioned vehicles and upfit costs;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that;

34 SECTION 1

36 The Executive is hereby authorized to advertise for bids for six (6) vehicles for the Sheriff’s
37 Office, for an estimated cost not to exceed \$365,550.00, including five (5) 2025 Ford Explorer
38 Police Interceptors AWD V6, one (1) 2025 Dodge Durango Pursuit Vehicle AWD, and the upfit
39 costs for all six (6) vehicles.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare
44 of the residents of the County of Summit, and for the further reason that it authorizes the Executive
45 to immediately advertise for bids in order to procure the necessary equipment within the grant
46 performance period.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
51 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
52 be in force at the earliest time provided by law.


