7 **A Resolution confirming the award by the Board of Control, subject to the approval of the**
8 **Information Technology Board, of a professional service contract with Adgators, for digital**
9 **signage and wayfinding for the Summit County Courthouse, in an amount not to exceed**
10 **\$87,344.00, for the Court of Common Pleas, and declaring an emergency.**

11

12 WHEREAS, the Ohio Supreme Court awarded a Technology Grant to the County of
13 Summit, in the amount of \$75,616.00, with no local cash match requirement, for digital signage
14 and wayfinding for the Summit County Courthouse; and

15

16 WHEREAS, the grant award covers a majority of the costs for digital signage and
17 wayfinding for the Summit County Courthouse complex, with a remaining amount of \$11,728.00
18 to be covered by the Court of Common Pleas' (the "Court") Special Project fund; and

19

20 WHEREAS, the Court wishes to contract with Adgators for digital signage and wayfinding
21 for the Summit County Courthouse, for a total amount not to exceed \$87,344.00, of which,
22 \$75,616.00 is covered by grant funding; and

24 WHEREAS, the Board of Control, at its meeting held December 4, 2024, awarded a
25 professional service contract with Adgators for the aforementioned services, which as a grant
26 contract and pursuant to Section 177.07(a)(12) of the Codified Ordinances of the County of
27 Summit is exempt from competitive bidding; and

29 WHEREAS, the Information Technology Board, at its meeting to be held on January 9,
30 2025, will consider the aforementioned professional service contract; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that the aforementioned professional service contract with Adgators is necessary and in the best
34 interest of the County of Summit;

36 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The award by the Board of Control of a professional service contract with Adgators, subject
42 to the approval of the Information Technology Board, for digital signage and wayfinding for the
43 Summit County Courthouse, in a total amount not the exceed \$87,344.00, is hereby confirmed and
44 the Executive is hereby authorized to execute said professional services contract and any other
45 necessary related documents.

49 This Resolution is hereby declared an emergency in the interest of health, safety, and
50 welfare of the residents of the County of Summit, and in order to expend the grant funds in a timely
51 manner.
