7 **A Resolution authorizing the Executive to execute an extension to the Intergovernmental**  
8 **Agreement with the City of Akron for the boarding at the Summit County Jail of**  
9 **misdemeanor offenders charged under a City of Akron ordinance or charged with**  
10 **contempt of an Akron Municipal Court Judge, for a term of six-months, from January 1,**  
11 **2025 to June 30, 2025, in an amount not to exceed \$2,464,348.50, for the Executive, and**  
12 **declaring an emergency.**

14 WHEREAS, since 1993, the County has boarded certain City of Akron offenders charged  
15 with misdemeanor offenses under a City of Akron ordinance or charged with contempt of an  
16 Akron Municipal Court Judge pursuant to an Intergovernmental Agreement with the City of  
17 Akron; and

19 WHEREAS, this Council previously passed Resolution No. 2024-056, authorizing the  
20 Executive to execute a one-year Intergovernmental Agreement with the City of Akron for the  
21 boarding of the aforementioned offenders that ended on December 31, 2024; and

23 WHEREAS, the Executive and Sheriff have negotiated an extension to the  
24 Intergovernmental Agreement with the City of Akron for the boarding at the Summit County Jail  
25 of misdemeanor offenders charged under a City of Akron ordinance or charged with contempt of  
26 an Akron Municipal Court Judge, for a term of six-months, from January 1, 2025 to June 30,  
27 2025 in an amount not to exceed \$2,464,348.50, a copy of which is attached hereto as Exhibit A  
28 and incorporated herein by reference; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
32 execute the aforementioned Intergovernmental Agreement;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

37 SECTION 1

39 The Executive is hereby authorized to execute an extension to the Intergovernmental  
40 Agreement with the City of Akron for the boarding at the Summit County Jail of misdemeanor  
41 offenders charged under a City of Akron ordinance or charged with contempt of an Akron  
42 Municipal Court Judge, for a term of six-months, from January 1, 2025 to June 30, 2025, in an  
43 amount not to exceed \$2,464,348.50, a copy of which is attached hereto as Exhibit A and  
44 incorporated herein by reference, with such modifications and revisions as shall be in furtherance  
45 of the provisions of said agreement, and not substantially adverse to the County, all of which  
46 shall be conclusively evidenced by the execution thereof by the Executive.

50 This Resolution is hereby declared an emergency in the interest of the health, safety and  
51 welfare of the residents of Summit County, and for the further reason to immediately authorize  
52 the aforementioned Intergovernmental Agreement.


