WHEREAS, this Council previously adopted Resolution No. 2020-091, which confirmed the award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for two full-time case managers and one full-time recovery support specialist, to provide support and treatment services to Valor Court participants, for a one-year term, from 9/30/19 through 9/29/20, in an amount not to exceed \$210,332.00; and

WHEREAS, this Council subsequently adopted Resolution No. 2021-015, which confirmed the award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for two full-time case managers and one full-time recovery support specialist, to provide support and treatment services to Valor Court participants, for a one-year term, from 9/30/20 through 9/29/21, in an amount not to exceed \$216,388.49; and
