7 **A Resolution confirming the award by the Board of Control of a purchase contract with**  
8 **Bob Maxey Ford Inc. for five (5) 2025 Ford Explorer Police Interceptors AWD V6, in a**  
9 **total amount not to exceed \$226,900.00, for the Sheriff, and declaring an emergency.**

10

11 WHEREAS, the Sheriff budgets for the periodical purchase of equipment and vehicles to  
12 replenish worn or past service life equipment and vehicles for use by the Sheriff's Office; and

13

14 WHEREAS, this Council previously adopted Resolution 2024-337, which authorized the  
15 Executive to advertise for bids for six (6) vehicles for the Sheriff's Office, for an estimated cost  
16 not to exceed \$365,550.00, including five (5) 2025 Ford Explorer Police Interceptors AWD V6,  
17 one (1) 2025 Dodge Durango Pursuit Vehicle AWD, and the upfit costs for all six (6) vehicles;

20 WHEREAS, due to high demand for such vehicles and low inventory nationwide is has  
21 been extremely difficult for the Sheriff to locate necessary vehicles for her fleet; and

23 WHEREAS, following the advertising of bids for this purchase, the Sheriff and the  
24 Executive wish to accept the sole bid submitted from Bob Maxey Ford Inc. for the  
25 aforementioned vehicles; and

27 WHEREAS, this purchase will mostly be paid with grant funding from the United States  
28 Department of Justice of a Bureau of Justice Assistance Byrne Discretionary Community Project  
29 Grant; and

31 WHEREAS, the Board of Control, at its meeting held on January 22, 2025, awarded a  
32 purchase contract with Bob Maxey Ford Inc., as the lowest responsive and responsible bid, for  
33 five (5) 2025 Ford Explorer Police Interceptors AWD V6, in a total amount not to exceed  
34 \$226,900.00, subject to confirmation by this Council; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
37 that the aforementioned purchase contract with Bob Maxey Ford Inc. is necessary and in the best  
38 interest of the County of Summit;

40 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
41 of Ohio, that:

45 The award by the Board of Control of a purchase contract with Bob Maxey Ford Inc., as  
46 the lowest responsive and responsible bid, for five (5) 2025 Ford Explorer Police Interceptors  
47 AWD V6, in a total amount not to exceed \$226,900.00, is hereby confirmed and the Executive is  
48 hereby authorized to execute said purchase contract and any other necessary related documents.

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.
