7 **A Resolution confirming the award by the Board of Control of a renewal (second of four) for**  
8 **a professional service contract with Oriana House, Inc. for community corrections services**  
9 **for a one-year term, from 1/1/25 through 12/31/25, in an amount not to exceed \$9,490,655.40,**  
10 **with three options to renew for an additional one-year term, for the Executive's Department**  
11 **of Public Safety, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2023-021, which confirmed  
14 the award by the Board of Control of professional service contract with Oriana House, Inc., for  
15 day reporting, driver intervention, home incarceration, multiple offender, and residential  
16 community correction programming, for a one year term, from 1/1/23 through 12/31/23, with four  
17 options to renew for an additional one-year term, in an amount not to exceed \$8,980,912.97, for  
18 the Executive's department of Public Safety; and

20 WHEREAS, this Council subsequently adopted Resolution No. 2024-013, which  
21 confirmed the award by the Board of Control of a renewal (first of four) of a professional service  
22 contract with Oriana House, Inc., for day reporting, driver intervention, home incarceration,  
23 multiple offender, and residential community correction programming, for a one year term, from  
24 1/1/24 through 12/31/24, in an amount not to exceed \$9,250,340.35, for the Executive's  
25 department of Public Safety; and

27 WHEREAS, the Board of Control, at its meeting held January 22, 2025, awarded a renewal  
28 (second of four) of a professional service contract with Oriana House, Inc. for community  
29 corrections services for a one-year term, from 1/1/25 through 12/31/25, in an amount not to exceed  
30 \$9,490,655.40, subject to confirmation by this Council; and

32 WHEREAS, this Council has determined by reviewing all pertinent information that the  
33 aforementioned renewal of a professional service contract with Oriana House, Inc. is necessary  
34 and in the best interest of the County of Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

41 The award by the Board of Control of a renewal (second of four) of a professional service  
42 contract with Oriana House, Inc. for community corrections services for a one-year term, from  
43 1/1/25 through 12/31/25, in an amount not to exceed \$9,490,655.40, is hereby confirmed and the  
44 Executive is hereby authorized to execute said renewal of a professional service contract and any  
45 necessary related documents.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and  
50 welfare of the residents of the County of Summit, and for the further purpose of immediately  
51 providing community corrections services effective 1/1/25.
