7 **A Resolution authorizing the Executive to advertise for bids for a mobile response trailer for**  
8 **the Summit County Special Operations Response Teams and special events, for an estimated**  
9 **amount not to exceed \$130,000.00, for the Executive’s Department of Public Safety,**  
10 **Emergency Management Agency and declaring an emergency.**

11

12 WHEREAS, the Executive wishes to advertise for bids for one (1) mobile response trailer  
13 for an estimated cost not to exceed \$130,000.00; and

14

15 WHEREAS, a mobile response trailer is a versatile and fully equipped unit that supports  
16 various operations, including emergency deployments, special events, incident management and  
17 emergency pipeline response activities; and

18

19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires  
20 this Council’s authorization for the Executive to advertise for bids; and

22 WHEREAS, copies of the bid specifications are on file in the Clerk of Council’s office;

25 WHEREAS, said equipment will be fully funded through the Pipeline Emergency  
26 Response Fund; and

28 WHEREAS, the Pipeline Emergency Response Fund provides for planning, training and  
29 equipment necessary to respond to emergencies in Summit County; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
33 advertise for bids the aforementioned equipment;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that;

40 The Executive is hereby authorized to advertise for bids for (1) mobile response trailer for  
41 the Executive’s Department of Public Safety, Emergency Management Agency, for an estimated  
42 cost not to exceed \$130,000.00.

46 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
47 of the residents of the County of Summit, and for the further reason that it authorizes the Executive  
48 to immediately advertise for bids in order to procure the necessary equipment within the grant  
49 performance period.
