7 **A Resolution confirming the award by the Board of Control of a renewal (second and final)**
8 **of a professional service contract with AdvizeX Technologies LLC, for PureStorage**
9 **Solution for SAN, for a one-year term, from 5/1/25 through 4/30/26, in an amount not to**
10 **exceed \$104,580.00, for the Office of Information Technology, and declaring an emergency.**

11

12 WHEREAS, AdvizeX was selected to replace the previous Information Technology
13 storage system that went out of support in October of 2023 and to provide additional storage
14 functionality and flexibility to increase storage with only additional subscription costs and no
15 additional hardware; and

16

17 WHEREAS, this Council previously adopted Resolution No. 2023-242, which confirmed
18 the award by the Board of Control of a professional services contract with AdvizeX; and

19

20 WHEREAS, subsequently, this Council adopted Resolution No. 2024-086, which
21 confirmed the award by the Board of Control of a renewal (first of two) of the aforementioned
22 professional services contract; and

24 WHEREAS, the Office of Information Technology recommends renewing the contract
25 with AdvizeX for continued service; and

26

27 WHEREAS, the Board of Control, at its meeting held on January 8, 2025, awarded,
28 subject to the approval of the Information Technology Board, a renewal (second and final) of a
29 professional service contract with AdvizeX Technologies LLC, for PureStorage Solution for
30 SAN, for a one-year term, in an amount not to exceed \$104,580.00, subject to confirmation by
31 this Council; and

33 WHEREAS, the Information Technology Board, at its meeting held on January 9, 2024,
34 approved the aforementioned contract; and

35

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that the aforementioned renewal of a professional service contract with AdvizeX Technologies
38 LLC is necessary and in the best interest of the County of Summit;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The award by the Board of Control of a renewal (second and final) of a professional
46 service contract with AdvizeX Technologies LLC, approved by the Information Technology
47 Board, for PureStorage Solution for SAN, for a one-year term, from 5/1/25 through 4/30/26, in
48 an amount not to exceed \$104,580.00, is hereby confirmed and the Executive is hereby
49 authorized to execute said renewal and any other necessary related documents.
