1 RESOLUTION NO. 2025-045 2 3 SPONSOR Executive Shapiro, Council as a Whole 4 5 DATE February 10, 2025 COMMITTEE Human Services 6 7 A Resolution declaring the month of March 2025 as Developmental Disabilities Awareness Month in Summit County, recognizing people with developmental disabilities for their 8 9 contributions to our community and their perseverance in breaking down barriers, for the Executive, and declaring an emergency. 10 11 12 WHEREAS, the National Association of Councils on Developmental Disabilities 13 celebrates March as Developmental Disabilities Awareness Month with an annual campaign to 14 raise awareness and increase the inclusion of people with developmental disabilities in all areas of 15 life, with the intention to highlight the barriers that inhibit people with developmental disabilities 16 from connecting to the communities in which they live; and 17 18 WHEREAS, it is important to recognize that the inclusion of people with developmental 19 disabilities creates strong, diverse communities where all residents are welcomed and valued; and 20 21 WHEREAS, the Ohio Developmental Disabilities Council and the Summit County 22 Developmental Disabilities Board ("Summit DD") participate in Developmental Disabilities 23 Awareness Month by hosting events and initiatives; and 24 25 WHEREAS, these events include Inclusion Day on March 3, 2025, on which Summit DD 26 celebrates by turning Summit County orange through clothes, stickers, signs, and social media 27 posts, and Inclusion Day at the Zoo, where the Akron Zoo partners with Summit DD to offer free 28 admission to visitors who wear orange between March 1 through March 3; and 29 30 WHEREAS, it is beneficial to promote these events so that residents of Summit County 31 with and without disabilities are encouraged to participate and do their part in coming together to 32 form a strong, inclusive community; and 33 34 WHEREAS, this Council finds and determines, after reviewing all pertinent information, 35 that it is necessary and in the best interest of the County of Summit that March 2025 be declared 36 Developmental Disabilities Month in Summit County, and encouraging the residents of Summit 37 County to join in this acknowledgement; 38 39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State 40 of Ohio, that: 41 42 **SECTION 1** 43 44 The month of March 2025 is hereby declared Developmental Disabilities Awareness 45 Month in Summit County, and the residents of Summit County are encouraged to join in this acknowledgement. 46 47 48 **SECTION 2** 49 50 This Resolution is hereby declared an emergency in the interest of the health, safety and 51 welfare of the residents and employees of the County of Summit and for the further purpose of 52
