A Resolution authorizing the publication and legal notices for the proposed public improvement known as the Springfield Lake Outlet (County Ditch No. 45) Improvements Project located in Springfield Township, and setting dates for the Public Viewing and Public Hearing pursuant to Section 6131.07 of the Ohio Revised Code, for Council, and declaring an emergency.

WHEREAS, a ditch petition was filed on January 14, 2025 pursuant to Section 6131.04 of the Ohio Revised Code requesting the County to repair the county ditch, which has caused flooding due to major storms in recent years and install measures to mitigate the erosive and flooding effect of future storms; and

WHEREAS, Section 6131.07 of the Ohio Revised Code requires a public viewing and public hearing, which will provide pertinent information from the County Engineer as to whether the construction of the combined improvement is necessary and conducive to the public welfare; and

WHEREAS, except as may be ordered pursuant to Section 6131.31 of the Ohio Revised Code, all costs of engineering, construction, and future maintenance will be paid by the Summit County Surface Water Management District; and

WHEREAS, the course and termini of the proposed combined improvement is shown on Exhibit A; and

WHEREAS, this Council has determined, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the publication and legal notice for the proposed public improvement located in Springfield Township, and to set the dates for the Public Viewing and Public Hearing pursuant to Section 6131.07 of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:
