7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Kenmore Construction Co., Inc., to replace the Mt. Pleasant Road Bridge, located in the**
9 **City of Green, in Council District 8, in an amount not to exceed \$737,822.00, for the**
10 **Engineer, and declaring an emergency.**

11

12 WHEREAS, the Engineer wishes to replace the poorly conditioned Mt. Pleasant Road
13 Bridge with a new bridge, located in the City of Green, in Council District 8 (the “Project”); and

14

15 WHEREAS, the Project will be a complete replacement of the existing 40 foot wider
16 structure with a prestressed box beam bridge that includes composite deck and triple steel tube
17 railing. Construction tasks will also include new pavement, approach slab, embankment,
18 guardrail, erosion protection, pavement marking and resurfacing; and

20 WHEREAS, this Council previously adopted Resolution No. 2024-346, which authorized
21 the Executive to advertise for bids as needed for road and bridge construction projects in the
22 Engineer’s 2025 Capital Improvement Program; and

24 WHEREAS, the Project was submitted to this Council as part of the Capital
25 Improvements Program for 2023-028; and

26

27 WHEREAS, the Engineer sent out seven bid packages for the Project and three bids were
28 received and the Executive selected Kenmore Construction Co., Inc. as the lowest responsive and
29 responsible bidder; and

31 WHEREAS, the Board of Control, at its meeting held February 12, 2025, awarded a
32 construction contract with Kenmore Construction Co., Inc., as the lowest responsive and
33 responsible bidder, to replace the Mt. Pleasant Road Bridge, located in the City of Green, in
34 Council District 8, in an amount not to exceed \$737,822.00, subject to confirmation by this
35 Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that the aforementioned construction contract with Kenmore Construction Co., Inc. is necessary
39 and in the best interest of the County of Summit;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The award by the Board of Control of a construction contract with Kenmore Construction
47 Co., Inc., to replace the Mt. Pleasant Road Bridge (the “Project”), located in the City of Green, in
48 Council District 8, in an amount not to exceed \$737,822.00, is hereby confirmed and the
49 Executive is hereby authorized to execute said construction contract and any other necessary
50 related documents.
