A Resolution confirming the award by the Board of Control of a renewal (first of three) of a professional service contract with Arcadis US, Inc. for an engineering services task order, for a one-year term, from 1/1/25 to 12/31/25, in an amount not to exceed \$175,000.00, for the Engineer, and declaring an emergency.

WHEREAS, the Engineer utilizes private construction inspectors for engineering, right of way acquisition, environmental data gathering and reporting, including the preparation of any necessary plans, documents, studies, and reports; and

WHEREAS, this Council previously adopted Resolution No. 2024-022, which confirmed the award by the Board of Control of a professional service contract with Arcadis US, Inc., as the firm that submitted the highest scoring technical proposal, for an engineering services task order, for a one-year term, from 1/1/24 to 12/31/24, with three options to renew for an additional one-year term, in an amount not to exceed \$175,000.00; and

WHEREAS, the Engineer recommends that the Executive enter into a renewal of the professional service contract with Arcadis US, Inc. for an engineering services task order, for a one-year term, from 1/1/25 to 12/31/25, in an amount not to exceed \$175,000.00; and

WHEREAS, the Board of Control, at its meeting held on February 12, 2025, awarded the aforementioned professional service contract with Arcadis US, Inc., subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that the aforementioned renewal of a professional service contract with Arcadis US, Inc., is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a renewal (first of three) of a professional service contract with Arcadis US, Inc. for an engineering services task order, for a one-year term, from 1/1/25 to 12/31/25, in an amount not to exceed \$175,000.00, is hereby confirmed, and the Executive is hereby authorized to execute said renewal and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide for a necessary engineering services task order for the Engineer's ongoing projects.
