7 **A Resolution accepting the amount and rate as determined by the Budget Commission, to**
8 **amend the levy of the Summit County Developmental Disabilities Board for the Tax Year**
9 **2024 from 4.5 mills to 3.59 mills, authorizing the necessary tax levy and certifying it for tax**
10 **year 2024/collection year 2025 to the Fiscal Officer, for the Executive’s Department of**
11 **Finance and Budget, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2024-274, accepting the
14 amounts and rates as determined by the Budget Commission, authorizing the necessary tax levies
15 and certifying them for tax year 2024/collection year 2025 to the Fiscal Officer; and

17 WHEREAS, subsequently, the Board of the Summit County Developmental Disabilities
18 Board, at its meeting on March 3, 2025 adopted Resolution No. 25-03-01, requesting the County
19 of Summit Budget Commission amend the levy of the Summit County Developmental
20 Disabilities Board for the Tax Years 2024 and 2025 from 4.5 mills to 3.59 mills, to reduce the
21 amount collected for the purpose of reflecting the will and intent of Summit County voters who
22 approved the collection of an estimated “66,121,000 Annually” which “amounts to \$158 for each
23 \$100,000 of the County Fiscal Officer’s Appraised Value” at the November 7, 2023 Election.

25 WHEREAS, subsequently, the Budget Commission of the County of Summit, at its
26 meeting on March 6, 2025, acted to amend the levy of the Summit County Developmental
27 Disabilities Board for the Tax Year 2024 from 4.5 mills to 3.59 mills, and to certify its action
28 thereon to this Council together with an estimate by the Fiscal Officer of the rate tax necessary to
29 be levied by this Council, and what part thereof is without, and what part is within, the ten mill
30 tax limitation; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that accepting the amended amount and rate determined by the Budget Commission for the levy
34 of the Summit County Developmental Disabilities Board for the Tax Year 2024 from 4.5 mills to
35 3.59 mills, authorizing the necessary tax levy and certifying it for tax year 2024/collection year
36 2025 to the Fiscal Officer is necessary and in the best interest of the County of Summit;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 The amount and rate as determined by the Budget Commission in its certification, to
44 amend the levy of the Summit County Developmental Disabilities Board for the Tax Year 2024
45 from 4.5 mills to 3.59 mills, attached hereto as Exhibit A and incorporated herein as if fully
46 restated, are hereby accepted. There is hereby levied on the tax duplicate of the County of
47 Summit the rate of each tax necessary to be levied within and without the ten-mill limitation.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the residents of the County of Summit and for the further reason that it is necessary to
8 comply in a timely manner with requirements by the State of Ohio that this Council accept the
9 rates as determined by the Budget Commission and authorize the necessary tax levies for tax
10 year 2024/collection year 2025 and certify them to the Fiscal Officer.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
22 deliberations of this Council and of any of its committees that resulted in such formal action,


