A Resolution approving salary adjustments for various classified non-bargaining employees, for the Prosecutor, and declaring an emergency.

WHEREAS, the Prosecutor wishes to grant salary adjustments for various classified non-bargaining employees in the General and Child Support Enforcement Agency divisions of his office based upon increased responsibilities and pay equity; and

WHEREAS, a copy of all the proposed salary adjustments including names, current and new positions, current and new class numbers, and current and new salaries is attached hereto as Exhibit A and incorporated fully herein; and

WHEREAS, because salary adjustments for the aforementioned employees represent pay increases under Section 169.07 of the Codified Ordinances of the County of Summit, this Council's approval is required; and

WHEREAS, the Director of the Department of Human Resources will review the personnel actions for the aforementioned salary adjustments as required by Section 169.07(b) of the Codified Ordinances of the County of Summit; and

WHEREAS, the salary adjustments will be submitted to the Director of the Department of Finance and Budget for the certification of availability of appropriated funds, as required by Section 169.07(b) of the Codified Ordinances of the County of Summit; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned salary adjustments are necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

This Council hereby determines that the Prosecutor has demonstrated that it is necessary for the effective and continued operation of his office to authorize the Prosecutor's Office to make the following salary adjustments retroactive to December 16, 2024 as defined on Exhibit A, which is attached hereto and incorporated fully herein.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately authorize the Prosecutor to timely make the aforementioned salary adjustments for the classified non-bargaining employees listed on Exhibit A.
