7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Melway Paving Company, Inc., for the 2025 Summit County 422 Resurfacing Program, in**
9 **an amount not to exceed \$776,443.60, for the Engineer, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2024-346, which authorized
12 the Executive to advertise, as needed, for bridge engineering and construction projects, and
13 pavement maintenance projects, for the Engineer’s 2025 Capital Improvements Program, and
14 federal and state funded projects, for an estimated total cost not to exceed \$9,160,000.00; and

15
16 WHEREAS, said projects were approved as part of the Capital Improvements Program
17 for 2025-2030 by Resolution No. 2025-034; and

18
19 WHEREAS, the work to be performed by Melway Paving Company, Inc. will consist of
20 resurfacing and pavement leveling and marking as required of various County, Copley
21 Township, Coventry Township, and Springfield Township roads, by applying 422 Chip Seal; and

23 WHEREAS, the contract total will be broken down by political subdivision as follows
24 with each subdivision responsible for directly paying the contractor:

- 26 County share: \$218,159.45
- 27 Copley Township: \$113,542.75
- 28 Coventry Township: \$200,713.20
- 29 Coventry Township Lot: \$16,878.45
- 30 Springfield Township: \$227,149.75; and

32 WHEREAS, following the receipt and review of four bids, the Executive proposes
33 entering into a construction contract with Melway Paving Company, Inc., for the 2025 Summit
34 County 422 Resurfacing Program, in an amount not to exceed \$776,443.60; and

36 WHEREAS, the Board of Control, at its meeting held on March 19, 2025, awarded a
37 construction contract with Melway Paving Company, Inc., as the lowest responsive and
38 responsible bidder, for the 2025 Summit County 422 Resurfacing Program, in an amount not to
39 exceed \$776,443.60, subject to confirmation by this Council; and

41 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
42 that the aforementioned construction contract with Melway Paving Company, Inc. is necessary
43 and in the best interest of the County of Summit;

45 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

6 The award by the Board of Control of a construction contract with Melway Paving
7 Company, Inc., for the 2025 Summit County 422 Resurfacing Program, in an amount not to

9 construction contract and any other necessary related documents.

13 This Resolution is hereby declared an emergency in the interest of the health, safety and
14 welfare of the residents of the County of Summit, and for the further purpose to immediately
15 providing a necessary construction contract for the 2025 Summit County 422 Resurfacing
16 Program.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
