A Resolution declaring April 2, 2025, as Start by Believing Day throughout the County of Summit, supporting the Start by Believing campaign which raises awareness of survivors of sexual violence, and encouraging all businesses and residents alike to show their support by wearing teal on April 2, 2025, for the Executive, and declaring an emergency.

WHEREAS, the County of Summit shares a critical concern for survivors of sexual violence and a desire to support their needs for justice and healing; and

WHEREAS, in 2024, law-enforcement agencies in Summit County received 325 reports of sexual assault, Cleveland Clinic Akron General Hospital's Providing Access to Healing Center provided services to 243 patients for reported sexual assaults, Hope and Healing Survivor Resource Center provided services to 229 survivors of sexual assault, the Victim Assistance Program provided services to 148 victims of sexual violence, and the Summit County Prosecutor's Office provided prosecutor-based victim-advocacy services to 155 adult and child survivors of sexual assault; and

WHEREAS, current estimates suggest as few as 1 in 5 sexual assaults will be reported to law enforcement and less than 3 percent will result in the conviction and incarceration of the perpetrator; and

WHEREAS, research documents that victims and survivors are far more likely to disclose their sexual assault to a friend or family member, and when these loved ones respond with doubt, shame, or blame, victims suffer additional negative effects on their physical and psychological well-being, and there is a higher probability of not reporting their victimization to law enforcement; and

WHEREAS, the Start by Believing public awareness campaign, a program of End Violence Against Women International and organized locally by the Prosecutor's Office, is designed to improve the responses of friends, family members, and community professionals, so they can help victims and survivors to access supportive resources and engage the criminal justice system;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

This resolution supports the Start by Believing public awareness campaign and do hereby declare April 2, 2025, to be Start by Believing Day throughout the County of Summit and encourage all businesses and residents alike to show their support by helping us Turn Summit Teal.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents and employees of the County of Summit and for the further purpose of immediately declaring April 2, 2025, as Start by Believing Day in Summit County.
