WHEREAS, additional vehicles were leased with Enterprise Fleet Management, Inc. and approved by Board of Control Directive No. 316-18 in the amount of \$46,261.12; Change Order No. 1 in the amount of \$12,789.39; and Directive No. 049-19 in the amount of \$32,094.40, for the total amount not to exceed \$286,468.31; and

WHEREAS, the Board of Control, at its meeting held on April 9, 2025, awarded Change Order No. 2 to the lease agreement with Enterprise Fleet Management, Inc., for eight vehicles for use by the Executive's Department of Sanitary Sewer Services that includes four Ford F-150 pickup trucks, one Ford F-250 4X4 super cab pickup truck, one Ford F-350 dump truck, one Ford F-550 pickup truck and one Chevrolet Silverado pickup truck, in an amount not to exceed \$45,830.67 (for a cumulative increase of 113.94%), for a total amount not exceed \$332,298.98; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that Change Order No. 2 to the lease agreement with Enterprise Fleet Management, Inc. is necessary and in the best interest of the County.
