A Resolution confirming the award by the Board of Control of a purchase contract with Aramark Correctional Services, LLC, as a Best Practical Source, for detention center youth food services, for a one-year term, from 7/1/25 through 6/30/26, with two options to renew for an additional one-year term, in an amount not to exceed \$4.323 to \$8.697 per meal based on the number of youth served and \$0.950 per snack, for a total amount not to exceed \$300,000.00 for the first year, for the Court of Common Pleas-Juvenile Division, and declaring an emergency.

WHEREAS, the Court of Common Pleas-Juvenile Division ("Juvenile Court"), is required to feed all youth housed at the detention center; and

WHEREAS, the Juvenile Court wishes to enter into a purchase contract with Aramark Correctional Services, LLC ("Aramark") to provide meals and snacks to the youth housed in the detention center in compliance with the National School Lunch Program; and

WHEREAS, Aramark is a Best Practical Source pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit because they have provided food services for the detention center since 2010 and due to their satellite kitchen they are able to provide the food services in the most cost-effective and expedient manner available for the detention center; and

WHEREAS, the Board of Control, at its meeting held April 2, 2025, awarded a purchase contract with Aramark Correctional Services, LLC, as a Best Practical Source, for detention center youth food services, for a one-year term, from 7/1/25 through 6/30/26, with two options to renew for an additional one-year term, in an amount not to exceed \$4.323 to \$8.697 per meal based on the number of youth served and \$0.950 per snack, for a total amount not to exceed \$300,000.00 for a total amount not to exceed \$300,000.00 for the first year, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Aramark is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
