A Resolution confirming the award by the Board of Control of a 60-month lease with Quadient Leasing USA, Inc., at State Term Pricing, for electronic certified mail, including software, licensing, subscription, folder management and support services, for the period 1/1/25 through 12/31/29, in an amount not to exceed \$100,113.60, for the Clerk of Courts, and declaring an emergency.

WHEREAS, the County Clerk of Courts Office handles approximately 20,000 pieces of certified mail annually and approximately 100,000 pieces over a five-year period; and

 WHEREAS, the Clerk of Courts desires to enter into a 60-month lease with Quadient Leasing USA, Inc. for electronic certified mail, including software, licensing, subscription, folder management and support services; and

WHEREAS, the cost of a traditional certified letter is approximately \$9.64, while an electronic certified letter will cost approximately \$8.16, which, with an electronically captured signature upon delivery, will no longer need the traditional green card, which costs approximately \$4.10 per letter; and

WHEREAS, the Clerk of Courts estimates that electronic certified mail will save approximately \$150,000.00 over the 60-month term of the proposed lease; and

WHEREAS, the Information Technology Board, at its meeting on April 10, 2025, approved the aforementioned lease with Quadient Leasing USA, Inc.; and

WHEREAS, the Board of Control, at its April 23, 2025 meeting, awarded a 60-month lease with Quadient Leasing USA, Inc., at State Term Pricing, approved by the Information Technology Board on April 10, 2025, for electronic certified mail, including software, licensing, subscription, folder management and support services, for the period 1/1/25 through 12/31/29, in an amount not to exceed \$100,113.60, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information that the aforementioned lease with Quadient Leasing USA, Inc., is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The award by the Board of Control of a 60-month lease with Quadient Leasing USA, Inc., at State Term Pricing, for electronic certified mail, including software, licensing, subscription, folder management and support services, for the period 1/1/25 through 12/31/29, in an amount not to exceed \$100,113.60, is hereby confirmed and the Executive is hereby authorized to execute said lease and any necessary related documents.
