Sims) 3 SPONSOR Executive Shapiro 4 5 DATE May 12, 2025 Planning COMMITTEE 6 7 A Resolution authorizing the Executive to execute a lease addendum with the Ohio 8 Department of Public Safety for office space at 1030 East Tallmadge Avenue, located in the 9 City of Akron, in Council District 6, for a two-year term, from 7/1/25 through 6/30/27, for 10 rent in the total amount of \$22,952.00, for the Executive, and declaring an emergency. 11 12 WHEREAS, the County and the Ohio Department of Public Safety ("ODPS") executed a 13 lease agreement in 2015 for approximately 1,425 square feet of office space located at 1030 East 14 Tallmadge Avenue, Akron, Ohio, as authorized by Resolution No. 2015-258; and 15 16 WHEREAS, the ODPS has continually paid rents due to the County throughout the terms of the lease and addendums and the state office operates in the same building where one of the 17 18 Summit County Clerk of Courts Title Bureau offices is located; and 19 20 WHEREAS, the Executive and ODPS wish to execute a new lease addendum, in a form 21 substantially similar to Exhibit A attached hereto and incorporated herein, for an additional two-22 year term, from 7/1/25 through 6/30/27, with monthly rent being \$956.34 per month, \$11,476.00 23 per year, \$22,952.00 for the term of the lease; and 24 25 WHEREAS, because ODPS is a department within the state of Ohio, pursuant to Section 26 177.17(e) of the Codified Ordinances of the County of Summit, the approval of the Board of 27 Control is not required; and 28 29 WHEREAS, this Council finds and determines, after reviewing all pertinent information, 30 that it is necessary and in the best interest of the County to authorize the Executive to execute said 31 lease addendum; 32 33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State 34 of Ohio, that: 35 36 **SECTION 1** 37 38 The Executive is hereby authorized to execute a lease addendum, in a form substantially 39 similar to Exhibit A attached hereto and incorporated herein, with the Ohio Department of Public 40 Safety for office space located at 1030 East Tallmadge Avenue, Akron, Ohio, for an additional 41 two-year term, from 7/1/25 through 6/30/27, with monthly rent being \$956.34 per month, 42 \$11,476.00 per year, \$22,952.00 for the term of the lease along with any necessary related 43 documents. 44 45 **SECTION 2** 46 47 This Resolution is hereby declared an emergency in the interest of the welfare of the 48 residents of the County of Summit, to allow residents local access to an Ohio Motor Vehicle Title 49 Office. 50 51 52
