A Resolution authorizing the publication and legal notices for the proposed public improvement known as the Copley Ditch (County Ditch No. 38) Improvements Project located in Copley Township, and setting dates for the Public Viewing and Public Hearing pursuant to Section 6131.07 of the Ohio Revised Code, for Council, and declaring an emergency.

WHEREAS, a ditch petition was filed on May 12, 2025 pursuant to Section 6131.04 of the Ohio Revised Code requesting the County to repair the county ditch, which has caused flooding due to major storms in recent years and install measures to mitigate the erosive and flooding effect of future storms; and

WHEREAS, Section 6131.07 of the Ohio Revised Code requires a public viewing and public hearing, which will provide pertinent information from the County Engineer as to whether the construction of the combined improvement is necessary and conducive to the public welfare; and

WHEREAS, except as may be ordered pursuant to Section 6131.31 of the Ohio Revised Code, all costs of engineering, construction, and future maintenance will be paid by the Summit County Surface Water Management District; and

WHEREAS, the course and termini of the proposed combined improvement is shown along with the Petition on Exhibit A; and

WHEREAS, this Council has determined, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the publication and legal notice for the proposed public improvement located in Copley Township, and to set the dates for the Public Viewing and Public Hearing pursuant to Section 6131.07 of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Pursuant to Section 6131.07 of the Ohio Revised Code, a legal notice shall be published one time in a newspaper of general circulation in Summit County; individual notice to all owners of land which will be benefitted or damaged by construction of the proposed improvement shall be sent by certified mail, return receipt requested, giving notice that a Public Viewing of the area will take place at 4:30 pm. on Monday, July 21, 2025 at Copley Township Administration Offices, 1540 S. Cleveland-Massillon Road, Copley, Ohio 44321, and that a Public Hearing will take place on Monday, September 8, 2025 at 4:30 pm in Council Chambers, Ohio Building – 7th Floor,
