7 **A Resolution authorizing the Executive to advertise for bids for the Canton Road and**
8 **Sanitarium Road Intersection Project, located in Springfield Township, in Council District**
9 **8, for an estimated total cost not to exceed \$396,178.48, for the Engineer, and declaring an**
10 **emergency.**

12 WHEREAS, the Engineer would like to improve the intersection of Canton Road and
13 Sanitarium Road, located in Springfield Township, in Council District 8 (the "Project"); and

14
15 WHEREAS, this Project will include the installation of a new traffic signal, signal
16 timing, pedestrian-friendly push buttons, ADA-compliant curbing and curb cuts, and the
17 construction of 500 feet of sidewalk on the west side of Canton Road for pedestrian access to
18 Springfield High School; and

20 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
21 requires this Council's authorization for the Executive to advertise for bids; and

22
23 WHEREAS, the Executive wishes to advertise for bids on behalf of the Engineer for the
24 Canton Road and Sanitarium Road Intersection Project, located in Springfield Township, in
25 Council District 8, for an estimated total cost not to exceed \$396,178.48; and

27 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;
28 and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that is necessary and in the best interest of the County of Summit to authorize the Executive to
32 advertise for bids for the Canton Road and Sanitarium Road Intersection Project, located in
33 Springfield Township, in Council District 8, for an estimated total cost not to exceed
34 \$396,178.48;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that;

41 The Executive is hereby authorized to advertise for bids for the Canton Road and
42 Sanitarium Road Intersection Project, located in Springfield Township, in Council District 8, for
43 an estimated total cost not to exceed \$396,178.48.

47 This Resolution is declared an emergency in the interest of the health, safety, and welfare
48 of the residents of the County of Summit, and for the further reason that it immediately
49 authorizes the advertisement for bids for necessary updates to the intersection.
