7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Cistones Excavating Services, LLC for the 2025 Summit County Culvert Replacement**
9 **Program, in an amount not to exceed \$126,182.20, for the Engineer, and declaring an**
10 **emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2024-346, which authorized
13 the Executive to advertise for bids as needed for road and bridge construction projects in the
14 Engineer's 2025 Capital Improvement Program at an estimated cost not to exceed
15 \$9,160,000.00; and

16
17 WHEREAS, the 2025 Summit County Culvert Replacement Program (the "Program")
18 was submitted to this Council as part of the Capital Improvements Program for 2025-2030; and

19
20 WHEREAS, the Program includes removal, replacement, and rehabilitation of CMP
21 culverts and pipe culverts also including the placement of rock channel protection and
22 construction of a concrete rip rap; and

23
24 WHEREAS, the proposed work sites are three County owned culverts, one on Boyden
25 Road in Sagamore Hills Township, one on Medina Line Road in Richfield Township, and the
26 other on Myersville Road in Springfield Township; and

27
28 WHEREAS, the Engineer distributed nine bid packages and following the receipt and
29 review of two bids, the Executive wishes to enter into a construction contract with Cistones
30 Excavating Services, LLC for the Program, in an amount not to exceed \$126,182.20; and

32 WHEREAS, the Board of Control, at its meeting held May 17, 2023, awarded a
33 construction contract with Cistones Excavating Services, LLC, as the lowest responsive and
34 responsible bidder, for the 2025 Summit County Culvert Replacement Program, in an amount
35 not to exceed \$126,182.20, subject to confirmation by this Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that the aforementioned construction contract with Cistones Excavating Services, LLC is
39 necessary and in the best interest of the County of Summit;

41 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The award by the Board of Control of a construction contract with Cistones Excavating
47 Services, LLC for the 2025 Summit County Culvert Replacement Program (the "Program"), in
48 an amount not to exceed \$126,182.20, is hereby confirmed and the Executive is hereby
49 authorized to execute said construction contract and any necessary related documents.

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.
