7 **A Resolution declaring the month of June 2025 as Alzheimer’s and Brain Awareness Month**  
8 **in Summit County, and to raise awareness about Alzheimer’s disease and other brain**  
9 **diseases and dementias, for the Executive, and declaring an emergency.**

10  
11 WHEREAS, the National Institute on Aging defines dementia as the loss the cognitive  
12 functions such as thinking, remembering, and reasoning to such an extent that it interferes with a  
13 person’s daily life and activities; and

14  
15 WHEREAS, Alzheimer’s disease is a progressive brain disease that leads to memory loss  
16 and cognitive decline and is the most common type of dementia; and

17  
18 WHEREAS, according to a report by the Alzheimer’s Association, nearly 7 million people  
19 in the United States are living with Alzheimer’s disease or related dementias, with that number  
20 expected to increase dramatically in the coming decades; and

21  
22 WHEREAS, women, Latino, and Black Americans are at a significantly higher risk for  
23 Alzheimer’s and dementia; and

24  
25 WHEREAS, symptoms of dementia include memory loss, confusion, difficulty speaking,  
26 writing, or reading, getting lost in a familiar place, acting impulsively, taking longer to complete  
27 simple tasks, loss of balance, and more; and

28  
29 WHEREAS, people living through all levels of severity of Alzheimer’s disease and  
30 dementia are worthy of compassion, respect, and dignity, and deserve the support of their family,  
31 friends, and community; and

32  
33 WHEREAS, while Alzheimer’s disease and dementias are not curable, there are strategies  
34 to prevent and treat dementias that can reduce future diagnoses and improve the prognoses of  
35 people living with these conditions; and

36  
37 WHEREAS, in 2023, Summit County was designated as a Dementia-Friendly Community  
38 and has embarked on a mission to better serve residents with dementia and to meet the needs of an  
39 increasing number of people living with dementia; and

40  
41 WHEREAS, an array of partners including the Akron-Summit County Public Library  
42 (“ASCPL”), the Summit County Developmental Disabilities Board, Summit County Public  
43 Health, Direction Home Akron Canton Area Agency on Aging & Disabilities, ASIA, and more  
44 continue to meet and lead this coalition; and

45  
46 WHEREAS, the work of Dementia Friendly Summit County and its partners includes  
47 Dementia Friends sessions, of which the coalition has presented over 40 sessions with more than  
48 900 participants, and ASCPL’s Dementia Inclusive resources and programming; and

49  
50 WHEREAS, these training programs are provided on a continual basis and have a ripple  
51 effect throughout Summit County and beyond as participants learn valuable skills they utilize in  
52 their work with clients and share with other providers, caretakers, and stakeholders; and

4 WHEREAS, Dementia Friends training is available to local institutions, businesses, and  
5 groups who want to learn how to better advocate for and support their neighbors and loved ones  
6 with dementia; and

7  
8 WHEREAS, Dementia Friendly Summit County will continue its work going forward to  
9 improve our community for residents with dementia; and

10  
11 WHEREAS, Alzheimer's and Brain Awareness Month is a time to uplift residents with  
12 dementia and the work to support them, recognizing how our loved ones with dementia fill our  
13 lives with joy, wit, humor, and love; and

14  
15 WHEREAS, this Council finds and determines, after receiving all pertinent information,  
16 that it is necessary and in the best interest of the County of Summit that June 2025 be declared  
17 Alzheimer's and Brain Awareness Month in Summit County, and encouraging the residents of  
18 Summit County to join in this acknowledgement;

19  
20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

24  
25 The month of June 2025 is hereby declared Alzheimer's and Brain Awareness Month in  
26 Summit County, and the residents and employees of Summit County are encouraged to join in this  
27 acknowledgement.

29 SECTION 2

30  
31 This Resolution is hereby declared an emergency in the interest of the health, safety and  
32 welfare of the residents and employees of the County of Summit and for the further purpose of  
33 immediately declaring June 2025 as Alzheimer's and Brain Awareness Month in Summit County.

35 SECTION 3

36  
37 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect  
39 and be in force at the earliest time provided by law.

41 SECTION 4

43 It is found and determined that all formal actions of this Council concerning and relating  
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
45 deliberations of this Council and of any of its committees that resulted in such formal action, were  
46 in meetings open to the public, in compliance with all legal requirements, including Section 121.22  
47 of the Ohio Revised Code.
