7 **A Resolution authorizing the Executive to advertise for bids for the Valley View Road**
8 **Resurfacing Project, located in Sagamore Hills Township, in Council District 1, for an**
9 **estimated total cost not to exceed \$1,409,424.66, for the Engineer, and declaring an**
10 **emergency.**

12 WHEREAS, the Engineer has determined there is a public need to improve 1.52 miles of
13 Valley View Road from Dunham Road to Olde 8 Road, including performing pavement repairs,
14 shoulder restoration, and resurfacing the pavement; and

15
16 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
17 requires this Council's authorization for the Executive to advertise for bids; and

18
19 WHEREAS, the Engineer estimates the cost of the bridge replacement to be
20 \$1,409,424.66; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
24 advertise for bids for the Valley View Road Resurfacing Project.

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The Executive is hereby authorized to advertise for bids for the Valley View Road
32 Resurfacing Project, located in Sagamore Hills Township, in Council District 1, at an estimated
33 cost not to exceed \$1,409,424.66.

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the residents of the County of Summit, and for the further reason that it will allow the
39 County to enhance vehicular safety in an expeditious fashion.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
