A Resolution confirming the award by the Board of Control of a construction contract with JD Stripping & Services, Inc. for the 2025 Regional Pavement Marking Program, in an amount not to exceed \$265,383.57, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2024-346, which authorized the Executive to advertise for bids as needed for road and bridge construction projects in the Engineer's 2025 Capital Improvement Program at an estimated cost not to exceed \$9,160,000.00; and

WHEREAS, the Project was submitted to this Council as part of the Capital Improvements Program for 2025-2030; and

WHEREAS, the Engineer sent out five bid packages and following the receipt and review of four bids, the Executive proposes entering into a construction contract with JD Stripping & Services, Inc., as the lowest responsive and responsible bidder, for the 2025 Regional Pavement Marking Program, in an amount not to exceed \$265,383.57; and

WHEREAS, the work to be performed by JD Stripping & Services, Inc. will consist of preparation of pavement and furnishing and installing of pavement markings per ODOT Item 642 specifications, including applying pavement marking paint for center lines, edge lines, and lane lines to various County, Village of Lakemore, Sagamore Hills Township and Springfield Township roads; and

WHEREAS, the contract total will be broken down by political subdivision as follows with each subdivision responsible for directly paying the contractor:

County share: \$246,787.84
Village of Lakemore: \$6,784.00
Sagamore Hills Township: \$6,876.69
Springfield Township: \$4,935.04; and

WHEREAS, the Board of Control, at its meeting held on May 21, 2025, awarded a construction contract with JD Stripping & Services, Inc., as the lowest responsive and responsible bidder, for the 2025 Regional Pavement Marking Program, in an amount not to exceed \$265,383.57, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with JD Stripping & Services, Inc. for the 2025 Regional Pavement Marking Program is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The award by the Board of Control of a construction contract with JD Stripping & Services, Inc. for the 2025 Regional Pavement Marking Program, in an amount not to exceed \$265,383.57, is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose to immediately provide necessary pavement marking to various County, Village of Lakemore, Sagamore Hills Township and Springfield Township roads in 2025.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
