A Resolution approving the Human Resource Commission revised Social Service Group (27000), 27051-27056 Series and the addition of a 27030-27031 Series, as outlined in Exhibit A, for the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, this Council has the authority pursuant to Article III, Section 3.03 (10) of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the Codified Ordinances of the County of Summit to establish classifications and classification specifications for all County employees; and

WHEREAS, the Executive's Department of Human Resources has requested the revision of various Social Service Group positions as outlined in Exhibit A, a copy of which is attached hereto and incorporated fully herein, due to the revisions made to the classification specifications to modernize the group and series to better align with the operations of the Executive's Department of Job and Family Services; and

WHEREAS, at its meeting held March 20, 2025, at the request of the Executive's Department of Human Resources, the Human Resource Commission approved a revised Social Service Group (27000), 27051-27056 Series and the addition of a 27030-27031 Series through its Order 25-01, a copy of which is attached hereto as Exhibit A and incorporated fully herein; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to confirm the Human Resource Commission revised Social Service Group (27000), 27051-27056 Series and the addition of a 27030-27031 Series due to the revisions made to the classification specification;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Order 25-01 of the County of Summit to confirm the Human Resource Commission revised Social Service Group (27000), 27051-27056 Series and the addition of a 27030-27031 Series, a copy of which is attached hereto as Exhibit A and incorporated fully herein, due to the revisions made to the classification specification is hereby confirmed and approved.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason that it is necessary in order to immediately approve the revised Social Service Group (27000), 27051-27056 Series and the addition of a 27030-27031 Series of the Executive's Department of Job and Family Services due to the revisions made to the classification specification.
