An amended Resolution to extend the final design report to October ~~August~~ 1, 2026 for Northfield Center Township's Norwood Lake, Beech Drive and Cherry Lane ditch petition pursuant to Section 6131.12 of the Ohio Revised Code, and declaring an emergency.

WHEREAS, on February 8, 2024, a single county petition for a drainage improvement was filed by Northfield Center Township with the Summit County Clerk of Council requesting the County to clean, remove obstructions from, restore, reconstruct and repair the drainage system discharging from Norwood Lake through the Norwood development and connecting with drainage infrastructure in the Route 82 right of way; and

WHEREAS, this Council previously adopted Resolution No. 2024-087 which authorized a viewing of the proposed improvement and set a public hearing pursuant to Section 6131.07 of the Ohio Revised Code; and

WHEREAS, a public viewing was held on May 16, 2024 and public hearing was held in Council Chambers on June 17, 2024; and

WHEREAS, after holding the public hearing on June 17, 2024, this Council adopted Resolution No, 2024-329 to authorize the Executive and the Engineer to solicit proposals for the preparation of plans, surveys, and project design, and set a date for the filing of such reports, plans, and schedules with this Council of August 1, 2025; and

WHEREAS, the Engineer has selected an engineering consultant to prepare reports, plans, and schedules, but said reports, plans, and schedules will not be completed until January 2026; and

WHEREAS, this Council wishes to extend the time for the filing of the reports, plans, and schedules as provided in Section 6131.12(C)(3) of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Pursuant to Section 6131.12(C)(3) of the Ohio Revised Code, this Council hereby extends the due date for the filing of reports, plans, and schedules to be prepared by the Engineer for the Norwood Lake, Beech Drive and Cherry Lane ditch petition to October ~~August~~ 1, 2026 from August 1, 2025 as previously directed in Resolution No, 2024-329.

SECTION 2
