7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Ports Petroleum Company, Inc. for unleaded and diesel fuel for general fleet operations, at**
9 **CUE pricing, for a one-year term, from 1/1/25 through 12/31/25, with one option to renew**
10 **for an additional one-year term, in an amount not to exceed \$300,000.00, for the Engineer,**
11 **and declaring an emergency.**

13 WHEREAS, the Engineer’s Office budgets annually for purchases of fuel, and in its 2025
14 general operating budget previously adopted by this Council in Resolution No. 2024-323,
15 \$300,000.00 was appropriated for said fuel purchases; and

16
17 WHEREAS, Ports Petroleum Company, Inc. is a contracted supplier under CUE pricing
18 for diesel and unleaded fuels and pursuant to Section 177.07(a)(8) of the Codified Ordinances of
19 the County of Summit is exempt from competitive bidding; and

21 WHEREAS, the Board of Control, at its meeting held on June 25, 2025, awarded a
22 purchase contract to Ports Petroleum Company, Inc., at CUE pricing, for unleaded and diesel
23 fuel for general fleet operations, for a one-year term, from 1/1/25 through 12/31/25, with one
24 option to renew for an additional one-year term, in an amount not to exceed \$300,000.00, subject
25 to confirmation by this Council; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that the aforementioned purchase contract with Ports Petroleum Company, Inc. for unleaded and
29 diesel fuel for general fleet operations is necessary and in the best interest of the County of
30 Summit;

32 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of a purchase contract with Ports Petroleum
38 Company, Inc. for unleaded and diesel fuel for general fleet operations, at CUE pricing, for a
39 one-year term, from 1/1/25 through 12/31/25, with one option to renew for an additional one-
40 year term, in an amount not to exceed \$300,000.00, is hereby confirmed and the Executive is
41 hereby authorized to execute said purchase contract and any other necessary related documents.

45 This Resolution is hereby declared an emergency in the interest of the health, safety, and
46 welfare of the residents of the County of Summit, and for the further reason to immediately
47 provide unleaded and diesel fuel for general fleet operations at the Engineer’s Office.
