7 **A Resolution confirming the award by the Board of Control of a professional service contract**
8 **with Greenleaf Family Center, as a Best Practical Source, to provide assessments to identify**
9 **court-involved individuals who may require enhanced programs or services, for the period**
10 **7/1/25 through 6/30/27, in an amount not to exceed \$374,400.00, for the Executive's**
11 **Department of Public Safety, and declaring an emergency.**

13 WHEREAS, the Summit County Court of Common Pleas (the "Court") must have the
14 ability to determine the proper level of treatment and services for court-involved individuals who
15 remain in local custody; and

16
17 WHEREAS, the State of Ohio, through the Ohio Department of Rehabilitation and
18 Correction ("ODRC") previously awarded Summit County a State Fiscal Year 26-27 Community
19 Corrections Act ("CCA") grant in the amount of \$7,779,284.00, for the period 7/1/25 through
20 6/30/27, with no local cash match requirement, to provide officials funding to house felony 4 and
21 5 offenders locally, in lieu of transferring them to state prison, and to provide alternative
22 community corrections programming and services for felony and misdemeanor offenders; and

24 WHEREAS, the Court has previously engaged Greenleaf Family Center ("Greenleaf") to
25 provide assessments, which are paid for through CCA funding, to ensure court-involved
26 individuals are receiving appropriate programs and services; and

28 WHEREAS, the Court wishes to continue to have Greenleaf provide assessments, for the
29 period of 7/1/25 through 6/30/27, in an amount not to exceed \$374,400.00, through the use of CCA
30 funding; and

32 WHEREAS, Greenleaf is a Best Practical Source pursuant to Sections 177.01(h)(4) and
33 177.07(a)(5) of the Codified Ordinances of the County of Summit as they have been providing
34 court assessment services for the Court since 2017, as well as providing similar assessment
35 services for various County agencies since 2009; and

37 WHEREAS, the Executive wishes to enter into a professional service contract with
38 Greenleaf to provide said assessments for court-involved individuals; and

40 WHEREAS, the Board of Control, at its meeting held June 25, 2025, awarded a
41 professional service contract with Greenleaf, as a Best Practical Source, to provide assessments to
42 identify court-involved individuals who may require enhanced programs or services, for the period
43 7/1/25 through 6/30/27, in an amount not to exceed \$374,400.00, subject to confirmation by this
44 Council; and

46 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
47 that the aforementioned professional service contract with Greenleaf is necessary and in the best
48 interest of the County of Summit;

SECTION 1

The award by the Board of Control of a professional service contract with Greenleaf Family Center, as a Best Practical Source, to provide assessments to identify court-involved individuals who may require enhanced programs or services, for the period 7/1/25 through 6/30/27, in an amount not to exceed \$374,400.00, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of health, safety, and welfare of the residents of the County of Summit, and for the further reason to continue to provide court assessments without interruption.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
